

Village of Industry Board of Trustees Meeting Minutes August 7, 2025 at 6:30pm Kiwanis Building

The Board of Trustees, Village of Industry, McDonough County, State of Illinois met on August 7, 2025. President Staci Danner called the meeting to order. Those answering roll call were Trustees Jones, Rittenhouse, Thompson, Wheeler, Murray and Drummond. Also present were Treasurer Black, Attorney Laegeler and Interim Clerk Larson. Superintendent Gorsuch was absent.

II. Benton & Associates

a. Doug was present and gave an update on the water meter replacement project. MB Construction should be notified as soon as possible if there are concerns. They will be responsible for any repairs if there were damages to property as a result of the installations. There were some additional locations and meters added to the project. Doug presented a change order with total additions of \$5534. Consensus to approve was received tonight and approval for the change order will be voted on at the September meeting.
