**ORDINANCE NO. 2024- 1**

**AN ORDINANCE TO AMEND THE INDUSTRY VILLAGE FEE SCHEDULE FOR WATER**

**WHEREAS**, the Village of Industry (“the Village”) is a municipality duly organized under the laws of the State of Illinois; and

**WHEREAS**, under State and local law, the Village Board of the Village of Industry (“the Village Board”) has the power to pass all necessary ordinances, rules, and regulations for the proper management and conduct of the Village’s business; and

**WHEREAS**, the Village Board, from time to time, has adopted ordinances which, in part, stated the fees charged by the Village for the provision of services by or on behalf of the Village or for the violation of certain ordinances (such as the fees identified in the revised water, wastewater, and garbage and trash ordinances); and

**WHEREAS**, the Village Board desires to codify the water fee schedule; and

**WHEREAS**, the amended Village Fee Schedule is attached to this Ordinance as an Exhibit A; and

**WHEREAS**, the Village Board deems it to be in the best interest of the Village to adopt the amended Village Fee Schedule, and to amend it from time to time rates are revised.

**NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF INDUSTRY, ILLINOIS, AS FOLLOWS:**

Section 1. The facts and statements contained in the preamble to this Ordinance are hereby found by the Village Board to be true and correct and are hereby adopted as part of this Ordinance.

Section 2. Amendment of Municipal Code. The Village Board hereby adopts the Amended Village Fee Schedule, to go into effect on June 1, 2024, a copy of which is attached as Exhibit A.

Section 3. Repeal of Inconsistent Provisions. To the extent any other ordinances, or parts of ordinances, in the Industry Code contain fee information that conflicts with the fee schedule, they are hereby repealed.

Section 4. Effective Date. This Ordinance shall be in full force and effect from and after its passage, approval, and publication pursuant to law.

## **EXHIBIT A**

### Village Water Fee Schedule – Effective June 1, 2024

a) All water charges shall be calculated monthly based on computations as set forth herein.

b) Minimum charges. For residential and commercial water customers the basic wastewater user charge shall be based on the customer's estimated monthly water usage or actual monthly water usage recorded by water meters. The minimum monthly water consumption for water billing purposes shall be two thousand (2,000) gallons per customer per month.

c) For the residential and commercial water customers located within the corporate limits of the village, the basic water user charge shall be thirty dollars (\$30.00) for the first two thousand (2,000) gallons of water usage per month (or any fraction thereof), plus six dollars (\$6.00) for each additional one thousand (1,000) gallons of water usage per month (or any fraction thereof).

d) Late charges. A 10% late fee will be added to water charges if not paid by the 10<sup>th</sup> day of each month. If the bill is not paid by the 20<sup>th</sup>, then the service is shut off on the 21<sup>st</sup>. There is a twenty-five dollar (\$25.00) reconnect fee.
